In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Emergency Regulations, 1942; and in the matter of the Northern, Wellington, and Canterbury Aircraft-workers' award, dated the 23rd day of June, 1948, and recorded in 48 Book of Awards 976.
