## NEW ZEALAND (EXCEPT NORTHERN INDUSTRIAL DISTRICT) DRESSMAKERS AND

 MILLINERS-AMENDMENT OF AWARDIn the Court of Arbitration of New Zealand.-In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Regulations 1952 ; and in the matter of the New Zealand (except Northern Industrial District) Dressmakers and Milliners award dated the 8th day of September 1950, and recorded in 50 Book of Awards 1185.

In pursuance and exercise of the powers vested in it by the Economic Stabilization Regulations 1952, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12 th day of July 1952, doth hereby order as follows :-

1. That the said award shall be amended in the manner following :-
(1) By deleting clauses 3 and 6 and substituting the following clauses :-

## " Female Apprentices and Improvers

" 3 . The minimum wage of female apprentices (whether their term of apprenticeship commenced under this award or any previous award) and improvers employed in any capacity shall be at the following weekly rates :-

"Provided that workers commencing over sixteen years of age shall receive 5s. 9d. per week in advance of the above rates, and over seventeen years of age 8 s . 8 d . per week in advance of the above rates, and over eighteen years of age 11s. 6 d . per week in advance of the above rates ; but this proviso shall not operate so as to increase journeywomen's rates: Provided, also, that workers over twenty-one years of age shall be paid not less than $£ 5$ per week."

## " Journeywomen's Wages

" 6 . (a) The minimum wage for journeywomen shall be $£ 66 \mathrm{~s}$. 10d. per week, and for journeywomen employed as cutters $£ 619 \mathrm{~s}$. 1 d . per week.
" (b) A female worker commencing at the trade when over twenty-one years of age shall be paid $£ 5$ per week for the first six months, $£ 56$ s. 3 d. per week for the second six months, $£ 512 \mathrm{~s} .6 \mathrm{~d}$. per week for the third six months, and thereafter at journeywomen's rates."
(2) By inserting after clause 8 the following new clause :-

## " Exclusion from Operation of General Order

" 9 . The rates of remuneration provided for in this award shall not be subject to the provisions of the general order of the Court, dated the 30th January 1951, and made under the Economic Stabilization Regulations 1950."
(3) By deleting from subclause (a) of clause 11 (Overtime) the figures and symbols " 2 s . 6 d ." and substituting the figures and symbols " $2 \mathrm{~s} .10 \frac{1}{2} \mathrm{~d}$."
2. That this order shall come into force on the 1st day of September 1952.
