DUNEDIN CITY COUNCIL ELECTRICITY DEPARTMENT EMPLOYEES— VARIATION OF INDUSTRIAL AGREEMENT

This industrial agreement made pursuant to the Industrial Conciliation and Arbitration Act, this 17th day of December, 1952, between the Dunedin City Council (hereinafter called the "employer") of the one part and the Dunedin Municipal Clerical and other Employees' (other than Inspectors) Industrial Union of Workers (hereinafter called the "union") of the other part, witnesseth that it is hereby mutually agreed between the employer and the union as follows:—
