INVERCARGILL CITY COUNCIL OFFICERS (OTHER THAN CLERICAL)—AMENDMENT OF INDUSTRIAL AGREEMENT

In the Court of Arbitration of New Zealand.—In the matter of the Industrial Conciliation and Arbitration Act, 1925, and the Economic Stabilization Regulations 1952; and in the matter of the Invercargill City Council Officers (other than Clerical) industrial agreement, made on the 30th day of August 1949, and recorded in 49 Book of Awards 2568.

IN pursuance and exercise of the powers vested in it by the Economic Stabilization Regulations 1952, and of every other power in that behalf thereunto enabling it, this Court, for the purpose of giving effect to the pronouncement made by it on the 12th day of July 1952, doth hereby order as follows :—

1. That the said industrial agreement shall be amended in the manner following :--

(1) By deleting clause 5 and substituting the following clause :---

" Remuneration and Salaries

"5. (a) The increments shown in the various sections shall be considered as annual increments and shall be paid according to years of service in each particular section.

"(b) All increase in salary shall be paid after twelve months' service with the Council dating from the commencement of such service.
