

NORTHLAND, THAMES, TAURANGA, BAY OF PLENTY, OPOTIKI, TAUMARUNUI,
WAIAPU **HOSPITAL BOARDS' CLERICAL WORKERS**—VARIATION OF
INDUSTRIAL AGREEMENT

[Filed in the Office of the Clerk of Awards, Auckland]

THIS Industrial Agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1925 and its amendments this 21st day of April 1954 between the Northland, Thames, Tauranga, Bay of Plenty, Opotiki, Taumarunui, Waiapu Hospital Boards (hereinafter referred to as "the employer") of the one part and the Auckland Provincial District Local Authorities' Officers' Industrial Union of Workers (hereinafter referred to as "the union") of the other part whereby it is mutually agreed by and between the said parties that the Industrial Agreement made between the parties on February 2nd 1954, shall be and is hereby varied in the manner following:

Increase in Rates of Remuneration

1. That the general order made by the Court of Arbitration on 19th November 1953, shall be deemed to be incorporated in this agreement and shall have effect according to its tenor in respect of all the herein rates of remuneration (except allowances for tools, bicycles, motor vehicles, protective or special clothing or special footwear) are increased by 10 per cent as from the 15th September 1953, excluding remuneration in excess of £12 each week in the case of adult males, £9 adult females and £7 workers under 21 years of age.

2. This agreement shall be deemed to have come into force on the 15th September 1953.
