

NEW ZEALAND (EXCEPT NORTHERN AND CANTERBURY) RETAIL GROCERS ASSISTANTS—ORDER EXTENDING SCOPE OF AWARD AND ADDING PARTIES

In the Court of Arbitration of New Zealand, Northern Industrial District—In the matter of the Industrial Conciliation and Arbitration Act 1954; and in the matter of the New Zealand (Except Northern and Canterbury) Retail Grocers Assistants Award, dated the 21st day of December 1957 and recorded in 57 Book of Awards 1859.
