NORTH CANTERBURY HOSPITAL BOARD LAUNDRY WORKERS—VARIATION OF INDUSTRIAL AGREEMENT

This industrial agreement made pursuant to the Industrial Conciliation and Arbitration Act 1954, and its amendments on 11 December 1959, between the North Canterbury Hospital Board (hereinafter called "the employer") of the one part, and the Christchurch Laundry Workers, Dyers, and Dry Cleaners' Industrial Union of Workers (hereinafter called "the union"), of the other part, witnesseth that is mutually agreed between the employer and the union as follows:

SCHEDULE

Except as hereinafter modified the terms and conditions of the North Canterbury Hospital Board Laundry Workers' Industrial Agreement, dated 11 December 1957 and recorded in Book of Awards, Vol. 57 p. 1821, shall be deemed to be incorporated in and form part of this agreement.

The modifications hereinbefore referred to are as follows:

Clause 3—Meal Money:

Delete, and substitute the following:

"The employer shall allow meal-money at the rate of 5s. per meal when workers are called upon to work overtime after 6 p.m."

Clause 4—Wages:

The following shall be the minimum rates of wages:

Delete subclause (a), and substitute the following:

This agreement, in so far as it relates to wages, shall be deemed to have come into force on 12 October 1959 and so far as all the other conditions of this agreement are concerned, it shall come into force on the day of the date hereof; and this agreement shall continue in force until 29 February 1960.
