NEW ZEALAND MOTOR TRADE EMPLOYEES-AMENDMENT OF AWARD

In the Court of Arbitration of New Zealand—In the matter of the Industrial Conciliation and Arbitration Act 1954 and the Economic Stabilisation Regulations 1953: And in the matter of the New Zealand Motor Trade Employees Award, dated the 3rd day of October 1958, and recorded in 58 Book of Awards 1553.

WHEREAS on the 18th day of September 1959 the Court made a pronouncement under regulation 5A of the Economic Stabilisation Regulations 1953; and whereas the New Zealand Engineering, Coachbuilding, Aircraft and Related Trades Industrial Union of Workers, a party to the above-mentioned award, has made application to the Court pursuant to regulation 5c of the said regulations to amend the said award by incorporating in such rates of remuneration as the Court thinks just and equitable, as an integral part of such rates, the effect of the general order dated the 18th day of September 1959; and whereas at the request of the Court made pursuant to paragraph 6 of the said regulation 5c the representatives of the original parties to the said award have conferred on the application and have sent to the Court the terms of the agreement arrived at; now, therefore, the Court, in pursuance and exercise of the powers conferred upon it by the said regulation 5c, doth hereby order as follows:

1. That the said award shall be amended in the manner following:

(1) By deleting subclauses (a) and (c) of clause 4 (Wages) and substituting the following subclauses:

(c) Kerrick Kleaner Operators—The minimum rates of wages shall be as follows:

Weekly worker substantially employed operating a Kerrick Kleaner and a weekly worker substantially employed as an underseal operator: £12 14s. 7d. per week.

Hourly rate for Kerrick Kleaner workers and underseal operators: 6s. 6d. per hour."

(2) By deleting subclause (d) of clause 9 (Conditions Relating to Garage Attendants) and substituting the following subclause:

"(d) Wages-The minimum rates of wages shall be as follows:

Garage attendants, weekly workers: £11 11s. per week.

Garage attendants, hourly workers: 5s. 10d. per hour.

A garage attendant substantially employed in a lubritorium on the complete lubrication of motor-vehicles shall be paid not less than 5s. $11\frac{1}{2}d$. per hour, or if employed by the week, £11 15s. 9d.

Assistants—The minimum weekly wages for garage assistants shall be as follows:

And thereafter, or on attaining the age of 21 years, not less than the appropriate adult rate according to the class of work he is called upon to perform."

(3) By deleting clause 11 and substituting the following clause:

"Requirements of Economic Stabilisation Regulations

11. No worker bound by this award shall in any week be paid a lesser amount by his employer than the worker would have been entitled to be paid under this award if it had specifically applied the general order of the Court dated 18 September 1959 otherwise than by incorporation pursuant to the pronouncement of the Court dated 18 September 1959."

(4) By deleting from the undermentioned clauses the figures and symbols set out in the first column hereunder and substituting in each case the figures and symbols set out in the second column hereunder.
