

**AUCKLAND HOSPITAL BOARD CLERICAL AND OTHER OFFICERS—
VARIATION OF INDUSTRIAL AGREEMENT**

THIS industrial agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1954, this 10th day of November 1965, between the Auckland Hospital Board and the Auckland Provincial District Local Authorities Officers' Industrial Union of Workers.

Whereby it is mutually agreed by and between the said parties that the industrial agreement made between the parties on the 14th day of January 1964, shall be and is thereby varied in the manner following:

(i) That clauses 3 (a), (b) and (c) be amended by deleting the Second and Third Schedules of Salaries specified therein and by inserting the following:

(ii) That clause 7 (b) be amended by deleting:

(b) The payment of overtime together with salary shall not exceed £1,465 per annum in respect of the period 1 April 1963 to 31 July 1963, the amount of £1,495 per annum between the period 1 August 1963 to 31 March 1964, the amount of £1,525 between the period 1 April 1964 to 25 August 1964 and £1,590 thereafter. For the purpose of this sub-clause salaries shall be deemed to include all additional payments referred to in clause 6, sub-clause (l) and (m)

and inserting:

(b) The payment of overtime together with salary shall not exceed £1,465 per annum in respect of the period 1 April 1963 to 31 July 1963, the amount of £1,495 per annum between the period 1 August 1963 to 31 March 1964, the amount of £1,525 between the period 1 April 1964 to 25 August 1964 and £1,610 thereafter. For the purpose of this sub-clause salaries shall be deemed to include all additional payments referred to in clause 6, sub-clause (l) and (m).

(iii) That the amendments provided for in the above clauses shall be deemed to come into force on the 26th day of August 1964.
