NEW ZEALAND (EXCEPT TARANAKI AND NORTHERN INDUSTRIAL DISTRICTS. OTHER THAN GISBORNE JUDICIAL DISTRICT) RETAIL GROCERS' ASSIS-TANTS—ORDER EXTENDING SCOPE TO INCLUDE TARANAKI INDUSTRIAL DISTRICT AND ADDING PARTIES

In the Court of Arbitration of New Zealand, Taranaki Industrial District—In the matter of the Industrial Conciliation and Arbitration Act 1954; and in the matter of the New Zealand (Except Taranaki and Northern Industrial Districts, Other Than Gisborne Judicial District) Retail Grocers' Assistants Award, dated the 19th day of November 1964, and recorded in 64 Book of Awards.

UPON reading the application to extend the New Zealand (Except Taranaki and Northern Industrial Districts, Other Than Gisborne Judicial District) Retail Grocers' Assistants Award, dated the 19th day of November 1964, so as to add parties in another industrial district, which application was made by the New Zealand Federated Shop Assistants Industrial Association of Workers, a party to the said award and was filed herein on the 23rd day of December 1964: And upon being satisfied that due notice of the said application has been given to the unions, persons, firms and companies hereinafter named, and that no written notice of opposition to the said application has been received by the Clerk of Awards: And upon being satisfied that conditions of employment or of trade are such as to make it equitable to do so, this Court, in pursuance and exercise of the powers conferred upon it by sections 158 and 160 of the Industrial Conciliation and Arbitration Act 1954, doth hereby make orders as follow:

1. That, subject to the condition that New Plymouth be deemed to be included in the towns of the category to which a radius of 5 miles has reference in clauses 3 (Hours of Work) and 27 (Opening and Closing of Shops) of the said award, the undermentioned unions, persons, firms, and companies be and they are hereby added as parties thereto:
