

NEW ZEALAND PAINTING AND DECORATING INDUSTRY—AMENDMENT OF  
APPRENTICESHIP ORDER

In the Court of Arbitration of New Zealand—In the matter of the Apprentices Act 1948; and in the matter of the New Zealand Painting and Decorating Industry Apprenticeship Order, dated the 8th day of March 1961, and recorded in 61 Book of Awards 179.

WHEREAS by section 13 (2) of the Apprentices Act 1948, the Court is empowered to amend any apprenticeship order: And whereas application has been made to the Court by the New Zealand Painting and Decorating Apprenticeship Committee for amendment of the New Zealand Painting and Decorating Industry Apprenticeship Order, dated the 8th day of March 1961, and recorded in 61 Book of Awards 179: And whereas the Court has considered the recommendations made to it by the said committee: Now, therefore, the Court, in pursuance and exercise of the powers vested in it by the said Act, doth hereby order as follows:

1. That the said apprenticeship order shall be amended in the manner following:
  - (1) By inserting the word “Second” before the word “Schedule” in clause 18 (Tools).
  - (2) By adding to clause 21 (Obligations of Employer) the following new subclause:

“(d) Every contract in the painting and paperhanging branch shall contain a list of the operations and skills to be taught the apprentice, in accordance with the First Schedule to this order.”

(3) By deleting the Schedule to the Order and substituting therefor the following Schedules:

#### “FIRST SCHEDULE

##### OPERATIONS AND SKILLS

##### *Painting and Paperhanging*

1. The correct use, care, and maintenance of normal painters’ scaffolding (trestles, ladders, steps, planks) not covered by the construction regulations and the proper procedure to be adopted when working on same.
2. The correct procedure in preparing surfaces prior to painting.
3. The correct use and care of trade tools generally used including brushes and personal equipment.
4. The correct painting procedure in the use of all sealers, undercoats, and finishing coats and also the correct use of solvents and thinners generally used in the trade.
5. Training in various decorative effects wherever possible.
6. Sufficient training in cutting glass to enable replacement of small sashes in renovation work.
7. A knowledge of correct behaviour and attitude on the job in relation to the client and others.
8. Additional or specialist finishes used in the trade as carried out by the employer.
9. *Paperhanging*—Preparation of all types of surfaces. The use and application of a comprehensive range of wall coverings including fabric backed materials. The uses and preparation of various pastes and adhesives.

#### SECOND SCHEDULE

##### *Painting and Paperhanging*

The following is a minimum list of painters’ and paperhangers’ tools as required for the full kit mentioned in clause 18 of this order: stopping knife, chisel knife, hacking knife, three-inch stripping knife, paperhangers’ laying-on brush, three-foot rule, pair of paperhangers’ scissors, tack hammer.

##### *Signwriters*

The following is a minimum list of signwriters’ tools as required for the full kit mentioned in clause 18 of this order: palette knife (small), putty knife, three-inch stripping knife, one and a quarter inch stopping knife, dusting brush, three-foot folding rule, gilding brush, knife, and tip (and pad if required), chamois leather, razor blade holder.

##### *Glazing*

The following is a minimum list of glaziers’ tools as required for the full kit mentioned in clause 18 of this order: wood chisel, hacking knife, glazing knife, dusting brush, glass cutter, glass pliers, wood pincers, claw hammer, pin hammer, punches (2), three-foot folding rule, suitable container.”

2. That this order shall operate and take effect as from the day of the date hereof.

1. That the said apprenticeship order shall be amended by adding to the First Schedule to the order the following operations and skills for glazing:

*Glazing*

1. The use and care of glazing tools and equipment.
  2. The correct use, care and maintenance of normal glazier's scaffolding (trestles, ladders, steps, planks) not covered by the construction regulations and the proper procedure to be adopted when working on same.
  3. Knowledge of the various types and weights of glass. Measuring, handling, stacking, loading and unloading glass for transportation and storage, setting-in, cutting (in shop and on site), glazing of all kinds of frames, cutting and glazing anti-glare and heat absorbing glass and shields.
  4. Knowledge of the various glazing compounds. Mixing and use of putties and glazing compounds.
  5. Preparing frames prior to glazing.
  6. Fixing of beads and gasket glazing.
  7. Fixing and fastening of vitrolite.
  8. Glazing and assembly of glass in show cases.
2. That this order shall operate and take effect as from the day of the date hereof.
