

**AUCKLAND HOSPITAL BOARD CLERICAL AND OTHER OFFICERS'—VARIATION  
OF INDUSTRIAL AGREEMENT**

THIS Industrial Agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1954, this twenty-fourth day of June 1966, between the Auckland Hospital Board and the Auckland Provincial District Local Authorities Officers' Industrial Union of Workers.

Whereby it is mutually agreed by and between the said parties that the Industrial Agreement made between the parties on the 15th day of November 1965, shall be and is thereby varied in the manner following:

(i) That Clause 3 (a) be amended by deleting the Schedule of Salaries specified therein and by inserting the following:
