## NORTHLAND, THAMES, TAURANGA, BAY OF PLENTY, OPOTIKI, TAUMARUNUI, AND WAJAPU HOSPITAL BOARDS' CLERICAL AND OTHER WORKERS'—VARIATION OF INDUSTRIAL AGREEMENT

This Industrial Agreement made in pursuance of the Industrial Conciliation and Arbitration Act, 1954 this 31st day of August 1966.

Between The Northland, Thames, Tauranga, Bay of Plenty, Opotiki, Taumarunui, Waiapu Hospital Boards and the Auckland Provincial District Local Authorities' Officers Industrial Union of Workers.
