

NORTH ISLAND CHEMICAL FERTILISER WORKERS—VARIATION OF AGREEMENT UNDER THE LABOUR DISPUTES INVESTIGATION ACT 1913

IN the matter of an agreement dated the 24th day of November 1965 between the—

Northern Branch, North Island Chemical Fertiliser Workers' Association (Inc.)
New Plymouth Branch, North Island Chemical Fertiliser Workers' Association (Inc.)

Wanganui Chemical Fertiliser Workers' Society,
and the—

Bay of Plenty Co-op Fertiliser Co. Ltd., Mt. Maunganui.
Challenge Phosphate Co. Ltd., Auckland.
Kempthorne Prosser & Co.'s N.Z. Drug Co. Ltd., Auckland and Wanganui.
Kiwi Fertiliser Co. Ltd., Morrinsville.
New Zealand Farmers' Fertiliser Co. Ltd., Auckland and New Plymouth.
Northland Fertiliser Co. Ltd., Whangarei.

It is hereby agreed between the parties that the agreement dated the 24th day of November, 1965 shall be varied in the manner following:

1. By deleting the note to clause 10 (a) thereof and substituting the following—
“Note: (1) The above rates take into account the working conditions associated with this industry.

(2) It is acknowledged by the parties to this agreement, and accordingly recorded:

(a) In recognition of conditions of extra fumes and dust which may from time to time be experienced by individual workers a further disability payment is warranted.

(b) Due to the difficulty in deciding the extent to which individual workers are affected it is agreed that a further payment of 3d. per hour be made in addition to the above rates."

2. That this variation of the agreement shall take effect from the first day of the pay period in each works commencing on or after the 21st day of October, 1966.
