- "(c) Except as provided in clause 2 (e) for work performed during a normal lunch break, no worker shall be employed longer than four and a half hours without an interval for a meal provided that a further half an hour may be worked at double time rates before the meal interval is allowed."
- 2. By deleting clause 2 (e) thereof and substituting the following—
- "(e) When any worker is required to work during all or part of his normal lunch break he shall receive the following extra payments:

Where up to and including one quarter hours is

worked 3 0 Where over one quarter hour is worked 6 0"

3. That this variation of the agreement shall take effect as from the 6th day of April, 1966.
