

ECONOMIC STABILISATION REGULATIONS 1953—EXCLUSIONS FROM
OPERATION OF GENERAL ORDER OF 10 NOVEMBER 1966

In the Court of Arbitration of New Zealand—In the matter of the Industrial Conciliation and Arbitration Act 1954; and in the matter of the Economic Stabilisation Regulations 1953.

IN pursuance and exercise of the powers conferred on it by regulation 4 (1) of the Economic Stabilisation Regulations 1953, and upon applications made in that behalf, the Court doth hereby order as follows:

1. That the provisions of the general order of the Court made under the said regulations and dated the 10th day of November 1966 shall not apply to the undermentioned industrial agreements and award and the workers whose employment is subject to the said industrial agreements and award are hereby excluded from the operation of that general order:

MEMORANDUM

This order is the outcome of several joint applications to the Court pursuant to regulation 4 (1) of the Economic Stabilisation Regulations 1953. The order is made at the request and with the consent of the parties concerned.

The special grounds stated in the applications in accordance with regulation 4 (3) are similar, and are to the effect that exclusion from the operation of the general order of the Court is necessary because it has been agreed by the respective parties that the wage or salary rates to be paid by the authorities concerned shall be related to the rates operating in the State Services and shall be amended from time to time to reflect any variations made by the State Services Commission following ruling rates surveys taken under section 42 of the State Services Act 1962.
