

**TARANAKI, WELLINGTON, MARLBOROUGH, NELSON, AND WESTLAND  
HOSPITAL BOARDS' CLERICAL WORKERS—AMENDMENT OF AWARD**

In the Court of Arbitration of New Zealand, Taranaki, Wellington, Marlborough, Nelson, and Westland Industrial Districts—In the matter of the Industrial Conciliation and Arbitration Act 1954; and in the matter of the Taranaki, Wellington, Marlborough, Nelson, and Westland Hospital Boards' Clerical Workers Award, dated the 23rd day of May 1966, and recorded in 66 Book of Awards.

UPON reading the joint application made on behalf of the original parties to the Taranaki, Wellington, Marlborough, Nelson, and Westland Hospital Boards' Clerical Workers Award, dated the 23rd day of May 1966: and upon being satisfied that all the original parties are desirous that the award should be reviewed

by it, the Court, in pursuance and exercise of the powers vested in it by section 162 (1) (b) of the Industrial Conciliation and Arbitration Act 1954, and with the consent of the said original parties, doth hereby order as follows:
