NORTHLAND, THAMES, TAURANGA, BAY OF PLENTY, OPOTIKI, TAUMARUNUI, WAIAPU HOSPITAL BOARDS' CLERICAL AND OTHER WORKERS'—VARIATION OF INDUSTRIAL AGREEMENT
