

NEW ZEALAND SHIP, YACHT, AND BOAT BUILDING INDUSTRY
-AMENDMENT OF APPRENTICESHIP ORDER

In the Court of Arbitration of New Zealand-In the matter of the Apprentices Act 1948; and in the matter of the New Zealand Ship, Yacht, and Boat Building Industry Apprenticeship Order dated the 16th day of December 1966, and recorded in 66 Book of Awards 2954.

Whereas by section 13 (2) of the Apprentices Act 1948, the Court is empowered to amend any apprenticeship order: And whereas application has been made to the Court by the New Zealand Shipwrighting, Boat Building and Coopering Apprenticeship Committee for amendment of the New Zealand Ship, Yacht, and Boat Building Industry Apprenticeship Order, dated the 16th day of December 1966, and recorded in 66 Book of Awards 2954: And whereas the Court has considered the recommendations made to it by the said Committee: Now therefore, the Court, in pursuance and exercise of the powers vested in it by the said Act, doth hereby Order as follows:

1. That the said apprenticeship order shall be amended by deleting subclause (a) of clause 11 (Wages) and substituting therefor the following subclause -

“(a) The minimum weekly rates of wages payable to apprentices shall be the under-mentioned percentages of an amount equal to forty times the minimum hourly wage rate for journeymen in the branch of the industry to which the apprentice is apprenticed, as prescribed by the award or agreement relating to the employment of such journeymen for the time being and from time to time in force in the establishment in which the apprentice is employed or if there is no such award or agreement, as prescribed by the award or agreement relating to the employment of such journeymen for the time being and from time to time in force in a locality including the City of Wellington:
