Dated 30/6/69

The industrial agreement made in pursuance of the Industrial Conciliation and Arbitration Act, 1954, and its amendments, on the 29th day of March, 1968, between the Auckland Journalists' Union on the one part and the Bay of Plenty Times Ltd., Tauranga, Gisborne Herald Ltd., Gisborne, Northern Publishing Co., Whangarei, Rotorua Newspapers Ltd., Rotorua, and the Waikato and King Country Press Ltd., Hamilton, on the other, is mutually agreed by and between the said parties to be varied this 30th day of June, 1969, as follows:
