AUCKLAND (30 MILE RADIUS) ELECTRICAL CONTRACTORS ELECTRICIANS-INDUSTRIAL AGREEMENT

This Industrial Agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1954, and its amendments, this 7th day of August, 1969, between the North Island Electrical and Related Trades Industrial Union of Workers, (hereinafter referred to as "the union") of the one part, and electrical contractors members of the Auckland Electrical Contractors Association (Inc) as listed, (hereinafter referred to as "the employer") of the other part, whereby it is mutually agreed by and between the parties hereto as follows:

1. That the terms, conditions, stipulations, and provisions contained and set out in the Schedule hereto shall be binding upon the parties hereto, and they shall be deemed to be and are hereby declared to form part of this agreement.

2. That the said parties hereto shall respectively do, observe, and perform every matter and thing by this agreement and by the said terms, conditions, stipulations and provisions respectively required to be done, observed and performed and shall not do anything in contravention of this agreement or of the said terms, conditions, stipulations and provisions, but shall in all respects abide by and perform the same.

SCHEDULE

INDUSTRY TO WHICH AGREEMENT APPLIES

1. This Agreement shall apply to electrical workers employed by electrical contractors, and engaged in that part of "electrical work" as defined in Clause 2, Interpretation, of the Northern, Taranaki, Wellington, and Otago and Southland Electrical Workers' Award, dated 1 November 1968, 68 Book of Awards, unpaged, as is applicable to the electrical contracting industry.

WAGES

2. The rate of \$1.08 per hour shall be paid to registered electrical journeymen.

GENERAL

3. (a) This agreement is made interms of subsection (i) of Section 103 of the Industrial Conciliation and Arbitration Act 1954.

(b) Nothing in this agreement shall affect the recommended wage rate of \$1.28 per hour and other conditions of the Memorandum of Agreement dated 7 August 1969, entered into between the North Island Electrical and Related Trades Industrial Union of Workers, Auckland Branch and the Auckland Electrical Contractors Association (Inc.) in following the recommendation dated 7 July 1969, made to these parties by the Committee of Inquiry appointed pursuant to Section 8 of the Industrial Relations Act.

SCOPE OF AGREEMENT

4. This agreement shall operate throughout that part of the Northern Industrial District lying within a radius of 30 miles from the Chief Post Office in the City of Auckland.

TERM OF AGREEMENT

5. This agreement shall come into force on 1 August 1969, and shall continue in force until 13 September 1970.
