# WELLINGTON DISTRICT ELECTRICAL CONTRACTORS ELECTRICIANS—INDUSTRIAL AGREEMENT

This industrial agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1954, and its amendments, this 14th day of October, 1969, between the North Island Electrical and Related Trades Industrial Union of Workers, (hereinafter referred to as "the union") of the one part, and electrical contractors members of the Wellington district Electrical Contractors' Association (Incorporated) as listed, (hereinafter referred to as "the employer") of the other part, whereby it is mutually agreed by and between the parties hereto as follows:

- 1. That the terms, conditions, stipulations, and provisions contained and set out in the Schedule hereto shall be binding upon the parties hereto, and they shall be deemed to be and are hereby declared to form part of this agreement.
- 2. That the said parties hereto shall respectively, do, observe, and perform every matter and thing by this agreement and by the said terms, conditions, stipulations and provisions respectively required to be done, observed and performed and shall not do anything in contravention of this agreement or of the said terms, conditions, stipulations and provisions, but shall in all respects abide by and perform the same.

#### SCHEDULE

## INDUSTRY TO WHICH AGREEMENT APPLIES

1. This agreement shall apply to electrical workers employed by electrical contractors, and engaged in that part of "electrical work" as defined in Clause 2, Interpretation, of the Northern, Taranaki, Wellington, and Otago and Southland Electrical Workers' Award, dated 1st November 1968, 68 Book of Awards, unpaged, as is applicable to the electrical contracting industry.

#### WAGES

2. The rate of \$1.16 per hour shall be paid to registered electrical journeymen.

#### GENERAL

- 3. (a) This agreement is made interms of subsection (i) of Section 103 of the Industrial Conciliation and Arbitration Act 1954.
- (b) Nothing in this agreement shall affect the recommended wage rate of \$1.28 per hour and other conditions of the Ruling Rate Agreement dated the 14th day of October 1969, entered into between the North Island Electrical and Related Trades Industrial Union of Workers, Wellington Branch and the Wellington District Electrical Contractors' Association (Incorporated).

## SCOPE OF AGREEMENT

4. This industrial agreement shall operate throughout those portions of the Wellington Industrial District which are comprised in the area of the Wellington Municipal Electricity Department and the Hutt Valley Electric Power and Gas Board, that is to say, the City of Wellington, the City of Lower Hutt, the City of Porirua, the City of Upper Hutt, the Borough of Tawa, the Borough of Petone, the Borough of Eastbourne, and the Hutt County including Somes Island but excluding the County Towns of Paekakariki and Paraparaumu and the riding of Paraparaumu.

## TERM OF AGREEMENT

5. This agreement shall come into force on the 14th day of October, 1969, and shall continue in force until the 13th September, 1970.
