

AMALGAMATED BRICK & PIPE CO. LTD.  
AND TITIAN POTTERY EMPLOYEES —  
VARIATION OF INDUSTRIAL AGREEMENT

This industrial agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1954 dated the 29th day of July 1970, between the Northern and Taranaki Labourers', General Workers and Related Trades Industrial Union of Workers and Related Trades Industrial Union of Workers of the one part and the Amalgamated Brick and Pipe Co. Ltd., Queens Arcade, Custom Street, Auckland I. and Titian Pottery Ltd., Great South Road, Takanini of the other part agree that the agreement dated 1st day of December 1969 shall be varied in manner as follows:

WAGES

Clause 10. (a) Delete and substitute:

- (a) The minimum rate of wages for a male worker 20 years of age or over shall be:

	Per Hour cents
Blockmaking and case making.....	104.6
Mould making.....	103.4
Making Flatware by jiggering process.....	101.5
Casting.....	101.5
Tube Mill, Filter press and workers handling clay in unprocessed state.....	101.5
Burning and Tunnel kiln attending.....	100.9
Packers.....	99.9
All others.....	98.3

YOUTHS

Clause 11. (a) Delete and substitute:

- (a) Male workers under 20 years of age shall be paid in accordance with the following scale:

	Per Week
Under 17 years of age.....	\$20.30
17 to 18 years of age.....	\$22.88
18 to 19 years of age.....	\$25.48
19 to 20 years of age.....	\$30.60

Thereafter the rate prescribed in Clause 10 for male workers over 20 years of age.

FEMALES

Clause 12. (a) Delete and substitute:

- (a) Female workers shall be paid in accordance with the following scale:

	Per Week
Under 17 years of age.....	\$18.20
17 to 18 years of age.....	\$20.00
18 to 19 years of age.....	\$22.72
19 to 20 years of age.....	\$24.56
20 years and over.....	\$27.88

#### TERM OF AGREEMENT

Clause 24. Delete and substitute:

This Agreement in so far as it relates to wages and other conditions shall be deemed to have come into force as from the first day of the pay week beginning after 31st May 1970 and shall continue in force until the 5th day of June 1971.
