PALMERSTON NORTH CITY COUNCIL GARDENERS, LABOURERS, AND OTHER WORKERS—VARIATION OF INDUSTRIAL AGREEMENT

This Industrial Agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1954, this 30th day of September 1970, between the Palmerston North City Council (hereinafter called "the employer") of the one part and the Wellington, Marlborough, Nelson and Westland Local Bodies, Other Labourers and Related Trades Industrial Union of Workers (hereinafter called "the union") of the other part, whereby it is mutually agreed by and between the said parties as follows:

1. That the terms and conditions, stipulations and provisions contained and set out in the Schedule hereto shall be binding upon the said parties and they shall be

deemed to be and are hereby declared to form part of this Agreement.

2. The said parties hereto shall respectively do, observe and perform every matter and thing by this Agreement and by the said terms, conditions, stipulations and provisions respectively required to be done, observed and performed and shall not do anything in contravention of this Agreement or of the said terms, conditions, stipulations and provisions but shall in all respects abide by and perform the same.

3. The Industrial Agreement dated July 4th, 1970 to which the employer and the union are parties is hereby amended and varied in accordance with the terms and provisions of the Schedule hereto, which Schedule shall stand part of the said Industrial Agreement.

SCHEDULE

1. Wages, Clause 3: Delete "89.6 cents per hour" in Clause 3 (a) and insert in lieu thereof—"104.6 cents per hour".

Delete "\$35.84 per week" in Clause 3 (a) and insert in lieu thereof—"\$41.84 per week".

- 2. Amend all wages rates in Clause 3 (c) by adding the sum of \$6.00 per week to each specified weekly wage rate shown therein.
- 3. Amend all wages in Clause 3 (k) by adding the sum \$6.00 per week to each specified weekly wage rate shown therein.

4. Insert an additional sub-clause (1) in Clause 3 as follows:—

- "The amended wage rates referred to herein shall have effect and become payable to the respective workers as from the first day of the pay week commencing on or after the 1st day of September, 1970.
- In the event of the Court of Arbitration issuing a General Wage Order during the currency of this agreement, such Order will apply to the wage rates as amended by this variation, notwithstanding any provision to the contrary contained in any General Wage Order".
