INDUSTRIAL CONCILIATION AND ARBITRATION ACT 1954— ORDER GRANTING EXEMPTION FROM AWARDS

New Zealand Plumbers and Gasfitters Award, dated the 21st day of October 1970; Northern, and Otago and Southland Industrial Districts Roof Tilers and Slaters Award, dated the 29th day of October 1970:

New Zealand Storemen and Packers Award, dated the 2nd day of October 1970; New Zealand (except Marlborough) Tinsmiths and Sheetmetal Workers Award, dated the 16th day of December 1970.
