

NEW ZEALAND DOMESTIC AIR SERVICES' HOSTESSES—  
ORDER VARYING APPLICATION OF GENERAL ORDER OF  
3 NOVEMBER 1970

In the Court of Arbitration of New Zealand—In the matter of the Industrial Conciliation and Arbitration Act 1954 and of the General Wage Orders Act 1969 and in the matter of the New Zealand Domestic Air Services' Hostesses Award, dated the 26th day of March 1970, and recorded in 70 Book of Awards 706.

Upon reading the joint application made by the New Zealand National Airways Corporation and the Airline Stewards and Hostesses of New Zealand Industrial Union of Workers, parties to the New Zealand Domestic Air Services' Hostesses Award, dated the 26th day of March 1970, the Court, in pursuance and exercise of the powers conferred on it by section 6 of the General Wage Orders Act 1969 and of every other power in that behalf enabling it, doth hereby order as follows:

1. That the workers whose employment is subject to the said award and employed by the New Zealand National Airways Corporation shall be excluded from the operation of the general order of 3 November 1970 in so far as the rates of remuneration determined by clauses 3 (a) and (b) and 7 (a) of the said award are concerned, but not otherwise.

2. That this order shall be deemed to have come into force on the 23rd day of November 1970.
