

NEW ZEALAND (EXCEPT NORTHERN INDUSTRIAL DISTRICT) WOOL,
GRAIN, HIDE, AND MANURE STORES' EMPLOYEES—
ORDER EXTENDING SCOPE AND ADDING PARTIES TO AWARD

In the Court of Arbitration of New Zealand, Northern Industrial District—In the matter of the Industrial Conciliation and Arbitration Act 1954; and in the matter of the New Zealand (except Northern Industrial District) Wool, Grain, Hide, and Manure Stores' Employees Award, dated the 3rd day of December 1971, and recorded in 1971 Book of Awards 3658.
