

**NEW ZEALAND (EXCEPT NORTHERN INDUSTRIAL OTHER THAN
GISBORNE JUDICIAL DISTRICT) DAIRY, CONFECTIONERY, AND
MIXED BUSINESS SHOP ASSISTANTS—ORDER EXTENDING
SCOPE AND ADDING PARTIES TO AWARD**

In the Court of Arbitration of New Zealand, Northern Industrial District—In the matter of the Industrial Conciliation and Arbitration Act 1954; and in the matter of the New Zealand (except Northern Industrial District other than Gisborne Judicial District) Dairy, Confectionery, and Mixed Business Shop Assistants Award, dated the 6th day of July 1971, and recorded in 71 Book of Awards 1985.
