# NEW ZEALAND BANK OFFICERS - INDUSTRIAL AGREEMENT

This industrial agreement made in pursuance of the Industrial Conciliation and Arbitration Act 1954 this 24th day of July 1972, between Australia and New Zealand Banking Group Limited, Bank of New South Wales, Bank of New Zealand, The Commercial Bank of Australia Limited, The National Bank of New Zealand Limited, all of Wellington duly incorporated companies and carrying on business of bankers in New Zealand and elsewhere and Databank Systems Limited of Wellington and elsewhere (hereinafter referred to as "the employers") of the one part and the New Zealand Bank Officers' Industrial Union of Workers of Wellington a duly registered Industrial Union (hereinafter referred to as "the Union"), of the other part whereby it is mutually agreed by and between the said parties hereto as follows, that is to say:

- 1. That the terms, conditions, stipulations and provisions contained and set out in the Schedule hereto shall be binding upon the said parties and they shall be deemed to be and are hereby incorporated in and declared to form part of this agreement.
- 2. The said parties hereto shall respectively do, observe, and perform every matter and thing by this agreement and by the said terms, conditions, stipulations and provisions respectively required to be done, observed and performed, and shall not do anything in contravention of this agreement or of the said terms, conditions, stipulations and provisions, but shall in all respects abide by and perform the same.

#### SCHEDULE

# APPLICATION OF AGREEMENT

1. The terms and conditions of the New Zealand Bank Officers' Award dated 9 October 1970 (No. 68/70) shall be incorporated in and declared to form part of this agreement, excepting that clause 4 of the said Award shall be varied to substitute the salaries hereinafter provided.
