## NEW ZEALAND BUILDING CADETS — AMENDMENT OF PRINCIPAL DETERMINATION UNDER THE TECHNICIANS TRAINING ACT 1967

This Determination made in pursuance of the Technicians Training Act 1967 this 31st day of October 1972 amends the Principal Determination on Conditions of Employment of Building Cadets made the 11th day of February 1969, in the manner following, that is to say:

- 1. By deleting subclauses 13.1.1 and 13.1.2 and substituting therefore the following subclauses:
- "13.1.1. Class A building cadets who are full-time students as defined in Clause A 13 of the Principal Training Scheme:

13.1.2. Class B building cadets who are part-time students as defined in Clause A 13 of the Principal Training Scheme:

Under the Principal Training Scheme a 'Class A building cadet' is a building cadet who during the first and second year of his contract attends a Technical Institute full-time during normal school hours and who is otherwise employed by his employer during normal school holidays, and who during the third and fourth years of his contract is employed full-time by the employer, subject to release for a minimum of six hours per week during normal working hours to attend Technical Classes and/or complete assignments provided by a Technical Correspondence Institute course. During the fifth year of his contract the Building Cadet will be employed full-time by the employer; while a 'Class B building cadet' is a building cadet who during the term of his contract is employed full-time by the employer, subject to release for a minimum of six hours per week during normal working hours to attend Technical Classes and/or complete assignments provided by a Technical Correspondence Institute course."

- 2. By deleting the figures and symbols "\$64.63" appearing in the last sentence of subclause 13.2.3 and substituting therefor the figures and symbols "\$69.85."
- 3. This determination shall be deemed to come into force on the first day of the pay week commencing on or after the 20th day of July 1972.

## NEW ZEALAND BUILDING CADETS — AMENDMENT OF PRINCIPAL DETERMINATION UNDER THE TECHNICIANS' TRAINING ACT 1967

This Determination made in pursuance of the Technicians' Training Act 1967 this 15th day of December 1972 amends the Principle Determination on Conditions of Employment of Building Cadets made on the 11th day of February 1969 in the manner of the following, that is to say:

1. By deleting subclause 19.1 and substituting therefore the following subclause:

"19.1 Every cadet shall at the end of the year of his employment become entitled to an annual holiday of two weeks paid on the basis of the cadet's average weekly taxable earnings: Provided that the holiday pay does not exceed the cadet's ordinary pay plus 30 percent and provided, further, that in no case shall the holiday pay be less than the cadet's ordinary pay at the time of taking the holiday. For the purpose of calculating a cadet's average weekly taxable earnings for the year the employer may fix a close-off date other than the anniversary date of the cadet's commencement of employment.

Upon completion of two years' continuous service with the same employer each cadet shall for the second and subsequent years be entitled to an annual holiday of three weeks instead of two weeks. The third week may be allowed either in conjunction with or separately from the first two weeks: Provided that where a cadet transfers to another employer his leave entitlement shall be decided by the Council at the time of transfer.

For the purposes of this clause lump sum special payments shall be excluded from the computation of average weekly taxable earnings, and ordinary pay shall be as defined in the Annual Holidays Act 1944."

This Determination shall come into force on the day of the date hereof.
