In the Court of Arbitration of New Zealand — In the matter of the Industrial Conciliation and Arbitration Act 1954 and the Equal Pay Act 1972 and the Economic Stabilisation Regulations 1973; and in the matter of the New Zealand (except Northern Industrial District other than Gisborne Judicial District) General Retail Shop Assistants Award, dated the 4th day of December 1972, and recorded in 72 Book of Awards 3846.

In pursuance and exercise of the powers conferred on it by subsection (4A) of section 4 of the Equal Pay Act 1972: And upon application made in that behalf by the duly authorised agents of the parties to the industrial dispute that was settled by the New Zealand (except Northern Industrial District other than Gisborne Judicial District) General Retail Shop Assistants Award, dated the 4th day of December 1972: And upon being satisfied that the application is for the purpose of giving effect to provisions of that Act and is not inconsistent with the requirements of the Economic Stabilisation Regulations 1973: The Court doth hereby order as follows:

- 1. That the said award shall be amended in the manner following —
- (1) By deleting subclauses (a) to (i) inclusive of clause 7 (Wages) and substituting therefor the following subclauses:

Workers engaged after the coming into force of this award who have passed the School Certificate Examination up to and including 1967 or who, subsequent to 1967, have obtained a School Certificate in English and three other subjects, shall be paid \$2 per week in addition to the above scale until the senior rate is reached; and workers engaged after the coming into force of this award who have passed the University Entrance Examination shall be paid \$4 per week in addition to the above scale until the senior rate is reached: Provided that only one examination shall be recognised in the case of each worker. The provisions of this paragraph shall not apply to temporary or casual hands or to workers engaged to work only during the period 1 to 24 December or to bona fide students employed during school or university vacations.

Without prejudice to subsequent negotiations in the matter of classification of shop assistants, employees who have successfully completed one academic year of courses recognised by the New Zealand Retailers' Federation Incorporated by notice in writing to the Head Office of the Department of Labour shall receive \$2 per week in addition to the scale rates until the senior rate is reached. This payment and the foregoing allowance, as

appropriate, shall be cumulative.

(b) The minimum rates of wages payable to the following classes of workers shall follow subclause (a) of this clause until the age of 21 is reached and thereafter shall be as follows:

Head Storeman — A "head storeman" is a storeman in charge of other workers. If in charge of two or more workers other than casuals and up to five such workers he shall be paid \$4 per week extra. If in charge of over five such workers he shall be paid \$6 per week extra.

## **MEMORANDUM**

The representatives of the parties advise that the provisions of this amending order provide for the first step in the implementation of equal pay by reducing the differentials between all male and female rates of wages by approximately one-fifth. The employers' representatives accept that the first increment only has been determined but record the fact that it is not their intention to bring about full implementation in fewer than four further steps. The union representatives for their part have not committed themselves beyond the first minimum step.

The rates of wages which have been amended by this order are inclusive of the effect of the August 1973 wage adjustment order under the Economic Stabilisation Regulations

1973.
