WELLINGTON HOSPITAL BOARD'S CLERICAL WORKERS – VARIATION OF INDUSTRIAL AGREEMENT

Dated 11/2/74

This industrial agreement, made in pursuance of the Industrial Conciliation and Arbitration Act 1954 this 11th day of February 1974, between the Wellington, Marlborough, Westland, Nelson and Taranaki Local Bodies' Officers Industrial Union of Workers (hereinafter called "the union") on the one part and the Wellington Hopital Board (hereinafter called "the employing authority") on the other part, whereby it is mutually agreed by and between the said parties that the main industrial agreement made between the said parties on the 16th day of July 1973 shall be varied in pursuance of Clause 3 (c) of the said industrial agreement in the manner following, that is to say:

1. By deleting (a) (i) (ii) (iii) (iv), (b) (i) (ii) of Clause 3 (RATES AND CON-DITIONS OF PAY) and subclause (g) of Clause 6 (OVERTIME) and substituting the following new subclauses therefor.

Provided that Clerical Assistants who have been on the 9th year of the scale for not less than one year may be advanced to the rate of \$4649 where, at the sole discretion of the Board, some advancement is justified on the basis of merit, proficiency, service, responsibility and the nature of the duties performed.

(b) Grade 2 and Grade Special - An officer may, at the discretion of the Board, be promoted to any step within the following grades if in the opinion of the Board some advancement beyond Grade 1 or Grade 2 is justified on the basis of merit, proficiency, service, responsibility and the nature of the duties performed.
