OTAGO HARBOUR BOARD EMPLOYEES – AMENDMENT TO AGREEMENT

Dated 9/8/76

In the Industrial Commission of New Zealand – In the matter of the Industrial Relations Act 1973; and in the matter of the Otago Harbour Board Employees Collective Agreement, dated the 15th day of December 1975.

In pursuance and exercise of the powers conferred upon it by section 97 (1) (b) of the Industrial Relations Act 1973; and upon application made in that behalf by the parties to the Otago Harbour Board Employees Collective Agreement, dated the 15th day of December 1975: and upon being satisfied that the parties to this collective agreement desire that it should be reviewed by it, the commission doth hereby order as follows:

1. That the said collective agreement shall be amended in the manner following:

(1) By renumbering present clause 1 to read clause 1 (a), and by inserting after this subclause (a) the following subclause -

"(b) If, during the currency of this agreement, the self-propelled trailer dredge "W. H. Resolution" is employed as a substitute dredge for "W. D. A. Endeavour," then each and every reference in this agreement to "W. D. A. Endeavour" shall be deemed to apply in equal context to "W. H. Resolution."

2. By inserting after subclause 3 (b) the following subclause:
