NEW ZEALAND FURNITURE, GLASSWORKING, AND WICKERWORKING INDUSTRIES – AMENDMENT OF APPRENTICESHIP ORDER

Dated 17/10/77

In the Industrial Court of New Zealand – In the matter of the Apprentices Act 1948; and in the matter of the New Zealand Furniture, Glassworking, and Wickerworking Industries Apprenticeship Order dated the 14th day of December 1973; recorded in 73 Book of Awards 5619.

Whereas by section 13 (2) of the Apprentices Act 1948, the Industrial Court is empowered to amend any apprenticeship order: And whereas application has been made to the Court by the New Zealand Furniture Trades Apprenticeship Committee for amendment of the New Zealand Furniture, Glassworking, and Wickerworking Industries Apprenticeship Order dated the 14th day of December 1973: And whereas the Court has considered the recommendations made to it by the said Committee: Now, therefore, the Court, in pursuance and exercise of the powers vested in it by the said Act, doth hereby order as follows:

1. That the said apprenticeship order shall be amended in the manner following:

1. By deleting sub-clause (g) of Clause 8 (Term of Apprenticeship) and substituting therefor the following new sub-clause:

"(g) Where a local committee is of the opinion that time served in a related occupation prior to the date of application for engagement of an apprentice should be credited to the apprentice, it may fix the term of apprenticeship."

2. By deleting from the Second Schedule the list of tools, etc. for the Cabinetmaking and Chairmaking Branches and substituting therefor the following new list:

"Cabinetmaking and Chairmaking – During the first 1000 hours of employment:

Apron, claw hammer, rule, pencil, cabinet scraper, sanding cork, nail punch, pin punch, 150 or 200mm square, iron jack place, iron smoothing plane, oilstone, oil can, small screwdriver, large screwdriver, pozi screwdriver, large bradawl, small bradawl, 12 and 25mm bevel edge chisels, marking gauge, 300 or 350mm tenon saw, Wilkins "Woodwork" (or such other book as may be approved by the New Zealand Committee).

During the second 1000 hours of employment:

Panel saw, spokeshave, marking point, brad hammer, 2, 5, 9 and 20mm bevel edge chisels, countersink, pliers, pincers, mortise gauge, bevel square. In addition to the foregoing it is recommended that any of the following tools

be supplied during the second 1000 hours of employment at the option of the employer: Small spiral ratchet screwdriver large spiral ratchet screwdriver brace and set

Small spiral ratchet screwdriver, large spiral ratchet screwdriver, brace and set of bits, hand drill, set of jobbers drills, push drill."

2. That this order shall operate and take effect as from the day of the date hereof.
