REGISTERED COLLECTIVE AGREEMENT

APPLICATION OF AGREEMENT

1. The Agreement shall apply to the Canterbury Clerks', Cashiers' and Office Employees Industrial Union of Workers, the clerical workes employed at the Dominion Hotel and the Dominion Hotel, 142 Gloucester Street, Christchurch 1.

DEFINITIONS

2. For the purpose of this Agreement the "Clerical Workers" shall have the same meaning as that prescribed by the New Zealand Licensed Hotel Clerical Workers' Award in force from time to time.

BOTTLE STORE ALLOWANCE HOTEL RECEPTIONISTS

3. In view of the nature of the working conditions related to the Hotel Receptionist in this establishment and the likelihood of damaged or soiled clothing as a result of those working conditions a reimbursing allowance of \$3.00 per week shall be paid to all hotel receptionists working in this establishment.

GENERAL

4. Except as herein modified the terms of employment of all workers bound by this Agreement shall be in accordance with the terms and conditions of the N.Z. Hotel Clerical Workers' Award in force from time to time.

TERMS OF AGREEMENT

5. This Agreement shall come into force on the 29th June, 1979 and shall continue in force until the 28th June, 1982.
