Under the Industrial Relations Act 1973

REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the New Zealand Press Association Journalists Dispute of Interest between New Zealand (except Northern Industrial District) Journalists and Related Trades Industrial Union of Workers and New Zealand Press Association.

The Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

In witness of the registration of this collective agreement the seal of the Arbitration Court has hereto been affixed and a Judge of the Court has hereunto set his hand, this 30th day of August 1979.

SUBMISSION OF VOLUNTARY SETTLEMENT FOR REGISTRATION

In the matter of the Industrial Relations Act 1973; and in the matter of the New Zealand Press Association Journalists dispute of interest between the New Zealand (except Northern) Journalists and Related Trades Industrial Union of Workers, P.O. Box 6545, Wellington, and the New Zealand Press Association Limited, Wellington.

To the Registrar of the Arbitration Court.

We hereby submit to you a signed copy of the terms of voluntary settlement of the above-mentioned dispute of interest arrived at by the parties pursuant to section 65 of the Industrial Relations Act 1973 for registration by the Arbitration Court as a Collective Agreement.

INDUSTRY TO WHICH AGREEMENT APPLIES

1. This agreement shall apply to workers falling within any of the definitions of clause 3 (Interpretations) of the award specified in clause 2 of this agreement who are employed in the operation of the New Zealand Press Association.

APPLICATION OF AGREEMENT

2. The provisions of the New Zealand (except Northern Industrial District) Daily Newspaper Journalists Award for the time being in force, shall apply to all workers except as provided in clauses 3, 4, 5, and 6 hereof.

WAGES

3. In return for recognition by the Wellington Branch of the New Zealand Journalists Union, and by those of its members employed by the New Zealand Press Association Limited, that it is the work of New Zealand Press Association staff to perform all duties arising from activities which come within the scope of the Memorandum of Association of New Zealand Press Association Limited, the New Zealand Press Association agrees to pay, in addition to the appropriate award rates, 7.5 percent of the ordinary salary as set out in clause 10 of the New Zealand (except Northern Industrial District) Daily Newspaper Journalists Award.

NIGHT SHIFT AND NIGHT SHIFT ALLOWANCE

4. Members of New Zealand Press Association staff rostered for the late night shift from 11.30 p.m. to 7.30 a.m. shall be rostered to have not fewer than five consecutive days on the shift and not more than seven. Where practicable, days off for these workers should be rostered consecutively. A worker rostered on the late night shift shall receive allowances totalling \$8.24 per night. This amount includes the award allowances for night shift workers with the balance to be regarded as a transport allowance. This allowance shall be paid in addition to penalty payments for weekend work as prescribed by subclause (b) of clause 8 of the award.

RESTRICTION OF NIGHT SHIFT ALLOWANCE

5. The term of the late night shift allowance specified in clause 4 of this agreement shall henceforth run concurrent with the term of the New Zealand (except Northern Industrial District) Daily Newspaper Journalists Award and on the next occasion that agreement is reviewed shall be increased to the extent of the monetary movement in the rate of allowance specified in paragraph (ii) of subclause (a) of clause 12 of that award.

TERM OF AGREEMENT

6. This agreement, in so far as the provisions relating to the rates of remuneration to be paid are concerned, shall be deemed to have come into force on the 23rd day of May 1979, and so far as all other provisions of this agreement are concerned, it shall come into force on the day of the date hereof; and this agreement shall continue in force until the 30th day of July 1980.

MEMORANDUM

The parties wish to record:

EIGHT-LEVEL TRANSMISSION

1. That on the introduction of eight-level transmission, current work practices will continue as before in so far as the receipt, editing, publication and transmission of eight-level messages is concerned.
2. That the only difference will be that copy will be in upper and lower case.
3. That copy will continue to be routed through sub-editorial departments.
4. That there will be no change to direct entry without the matter first having been negotiated with the NZJU. Failing agreement on this matter the parties agree to meet under the chairmanship of a conciliator.

VDUs

5. That an in-house committee comprising two chapel and two management representatives shall be formed to monitor the working conditions associated with VDUs at the NZPA office.

MEMORANDUM

This collective agreement incorporates the terms of voluntary settlement arrived at by the parties and forwarded to the Court for registration pursuant to section 65 of the Industrial Relations Act 1973.

Having regard to prevailing circumstances the court has, pursuant to section 92 (2) of the Industrial Relations Act 1973, consented to the specified period for which this collective agreement is to continue in force being less than one year from the date of registration.

This collective agreement supersedes the New Zealand Press Association Journalists — Collective Agreement (Conciliated) dated 21 December 1977 recorded in the Book of Awards Volume 77 Page 8847.
