NEW ZEALAND MOULDING INDUSTRY — AMENDMENT OF APPRENTICESHIP ORDER

Dated 19.11.80

In the Arbitration Court of New Zealand — In the matter of the Apprentices Act 1948; and in the matter of the New Zealand Moulding Industry Apprenticeship Order dated the 4th day of October 1967 and recorded in 67 Book of Awards 2358; as amended on the 24th day of May 1968 and recorded in 68 Book of Awards 270; as amended on the 11th day of February 1969 and recorded in 69 Book of Awards 171; as amended on the 14th day of July 1972 and recorded in 72 Book of Awards 2861; as amended on the 22nd day of May 1974 and recorded in 74 Book of Awards 201; as amended on the 15th day of August 1974 and recorded in 74 Book of Awards 429 and as amended on the 2nd day of July 1976 and recorded in 76 Book of Awards 3347.

Whereas by section 13 (2) of the Apprentices Act 1948, the Arbitration Court is empowered to amend any apprenticeship order: and whereas application has been made to the Court by the New Zealand Boilermaking and Moulding Industries Apprenticeship Committee for amendment of the New Zealand Moulding Industry Apprenticeship Order dated the 4th day of October 1967, as amended on the 24th day of May 1968; the 11th day of February 1969; the 14th day of July 1972; the 22nd day of May 1974; the 15th day of August 1974 and the 2nd day of July 1976: and whereas the Court has considered the recommendations made to it by the said Committee: now, therefore, the Court, in pursuance and exercise of the powers vested in it by the said Act, doth hereby order as follows:

1. That the said apprenticeship order shall be amended in the following manner:

(1) By deleting subclause (b) of clause 8 (Term of Apprenticeship) and

substituting therefor the following:

"(b) For an apprentice who has obtained a pass in School Certificate subjects giving admission to Form VI under Education Department, criteria, or in that examination has obtained not less than 50 percent of the possible marks in any two of the following subjects — English, mathematics, technical drawing, applied mechanics, engineering shopwork, workshop technology, science, alternative science, physics, chemistry, physical science — the term of apprenticeship shall be 8000 hours divided into eight 1000 hour periods, provided that where such passes are obtained after the commencement of a contract the term of apprenticeship shall be reduced by 1,000 hours, effective from the date evidence of the pass is produced to the employer."

(2) By deleting subclause (bb) of clause 8.

2. That this order shall operate and take effect from the day of the date hereof.
