NEW ZEALAND GOLF COURSES GREENKEEPING INDUSTRY —  
AMENDMENT OF APPRENTICESHIP ORDER

Dated 18/3/80

In the Arbitration Court of New Zealand — In the matter of the Apprentices Act 1948; and in the matter of the New Zealand Golf Course Greenkeeping Industry Apprenticeship Order dated the 3rd day of April 1970 recorded in 70 Book of Awards 825; as amended on the 20th day of October 1972 recorded in 72 Book of Awards 3530; and as amended on the 31st day of March 1977 recorded in 77 Book of Awards 3575.

Whereas by section 13 (2) of the Apprentices Act 1948, the Arbitration Court is empowered to amend any apprenticeship order: and whereas application has been made to the Court by the New Zealand Golf Courses Greenkeeping Industry Apprenticeship Committee for amendment of the New Zealand Golf Course Greenkeeping Industry Apprenticeship Order dated the 3rd day of April 1970, as amended on the 20th day of October 1972 and the 31st day of March 1977; and whereas the Court has considered the recommendations made to it by the said Committee: now, therefore, the Court, in pursuance and exercise of the powers vested in it by the said Act, doth hereby order as follows:

1. That the said apprenticeship order shall be amended by deleting subclause (a) (i) of clause 10 (Wages) and substituting therefor the following:  
“10. Wages — (a) (i) The minimum weekly rates of wages payable to apprentices shall be the undermentioned percentages of an amount equal to 40 times the minimum hourly rate for First Class Greenkeepers, as prescribed by the Golf Club Greenkeepers Award, in operation in the appropriate industrial district for the time being and from time to time in force.

For apprentices serving an 8,000-hour term of apprenticeship:

For apprentices serving a 7,000-hour term of apprenticeship:

First 1,000-hour period .....	54
Second 1,000-hour period .....	60
Third 1,000-hour period .....	66
Fourth 1,000-hour period .....	72
Fifth 1,000-hour period .....	78
Sixth 1,000-hour period .....	84
Seventh 1,000-hour period .....	90

2. That this order shall operate and take effect as from the day of the date hereof.
