AGREEMENT BETWEEN THE NEW ZEALAND CO-OPERATIVE DAIRY COMPANY LIMITED AND THE NORTHERN INDUSTRIAL DISTRICT STOREMEN PACKERS AND WAREHOUSE EMPLOYEES INDUSTRIAL UNION OF WORKERS.

The above mentioned parties agree that the following terms and conditions shall apply to all employees of the New Zealand Co-operative Dairy Company Limited who are members of the N.I.D. Storemen Packers and Warehouse Employees Industrial Union of Workers.

1. In place of rates of remuneration in Clause 7b of the N.I.D. Storemen Packers and Warehouse employees award the following rates shall apply:

Packers and Warehouse employees award the following rates shall apply:	
i) A worker with less than one month service	\$151.20
ii) A worker after one month with less than four months service	\$155.06
iii) A worker with more than four months service	\$158.88
iv) A worker employed in the Instrument Store at Te Rapa	\$159.85
v) Workers designated as forklift operators:	
a) with less than one month service	\$156.72
b) after one month and less than four months service	\$160.58
c) After four months service	\$164.40
vi) Standby forklift operators shall be paid 13.8 cents per hour whilst	
operating forklifts.	

## CLOTHING

2. Any worker required to work outside shall be supplied with a swanee/swandri.

## STOPWORK MEETINGS

3. Two meetings per year as provided in Clause 32 of the N.I.D. Storemen Packers and Warehouse Employees Award shall be paid.

# **UNDERSTANDING**

4. The Union will give consideration to the essential nature of the industry prior to taking any direct action.

# OTHER CONDITIONS TO APPLY

5. In all other respects the conditions of the N.I.D. Storemen Packers and Warehouse Employees Award shall apply.

## **REMUNERATION REGULATIONS 1979**

6. The rates of remuneration determined by this agreement are NOT to be increased by the application of the provisions of the general increase provided by the Remuneration (General Increase) Regulations 1979.

#### TERM

7. This agreement shall be deemed to come into force on the 29th November, 1979 and shall continue in force until the 28 November, 1980.

# **MEMORANDUM**

The parties agree that the rates for forklift operators be discussed during the currency of this agreement with particular reference to the introduction of a mutually agreed training programme. Any rate of remuneration agreed to as a result of these discussions shall be implemented on the expiry of this agreement.
