SUBMISSION OF VOLUNTARY AGREEMENT

In the matter of the Industrial Relations Act 1973 and in the matter of the Joint Council for Local Authorities Services Salaried Employees. Dispute between the Joint Council for Local Authorities Services Salaried Employees Society (Not Incorporated) and the Joint Council for Local Authorities Services.

To the Registrar of the Arbitration Court:

We hereby submit to you a signed copy of the terms of a voluntary agreement arrived at by the parties pursuant to Section 141 of the Industrial Relations Act 1973.

**JOINT COUNCIL FOR LOCAL AUTHORITIES SERVICES
SALARIED EMPLOYEES SOCIETY (NOT INCORPORATED)
VOLUNTARY AGREEMENT**

This Agreement made in pursuance to Section 141 of the Industrial Relations Act 1973 this 24th day of January 1980 between the Joint Council for Local Authorities Services (hereinafter called the "Joint Council" or "the Employer") of the one part and the Joint Council for Local Authorities Services Salaried Employees Society (Not Incorporated) (hereinafter called "the Society") of the other part whereby it is mutually agreed by and between the said parties as set out in the following schedule:

SCHEDULE

APPLICATION OF AGREEMENT

1. This Agreement shall only apply to the positions of Chief Executive Officer, Executive Assistant (Admin Officer) and Executive Assistant (Accountant).

TERMS AND CONDITIONS OF EMPLOYMENT

2. The terms and conditions of employment, other than salaries, for the Chief Executive Officer and the two Executive Assistants shall be equal to the terms and conditions of employment contained in the "Wellington City Council Municipal Officers Voluntary Collective Agreement Under the Industrial Relations Act 1973" filed with the Registrar, Arbitration Court, Wellington on 17th December 1979 or such other voluntary agreement which may be substituted therefore from time to time. This agreement shall not apply to the Chief Executive Officer after the date from which the determination of the Higher Salaries Commission applies.

SALARIES

3. The salaries applying as at 1st December 1978, excluding the 7% General Wage Order of 17.7.78 are:

Chief Executive Officer	\$ 20,000
Executive Assistant (Admin Officer)	\$ 14,000
Executive Assistant (Accountant)	\$ 14,000

STATE LINKAGE

4. The annual rates of remuneration provided for in this Agreement are related to the rates in the scale of annual salaries of the 007 Executive/Clerical occupational classes in the State Services. The aforesaid rates shall be amended from time to time both as to date of application and quantum of adjustment in accordance with salary determinations issued by the State Services Commission as a result of any half-yearly, yearly or specific reviews undertaken in accordance with the provisions of Section 30 or Section 31 of the State Services Conditions of Employment Act 1977.

TERM OF AGREEMENT

5. This Agreement shall be deemed to have come into force on the 1st day of December 1978 in respect to salaries, and from the date of filing in respect to the terms and conditions of employment and this Agreement shall continue in force until the 30th day of November 1980.
