ROTORUA DISTRICT COUNCIL SENIOR OFFICERS' COLLECTIVE AGREEMENT

This Agreement made in pursuance of the Industrial Relations Act 1973 this 21st October 1981 between the Rotorua District Council (hereinafter called "the Council" or the "employer") of the one part and the Auckland Provincial District Local Authorities Officers' Industrial Union of Workers (hereinafter

called "the Union") of the other part whereby it is mutually agreed by and between the said parties as set out in the following Schedule:

SCHEDULE

SCOPE OF AGREEMENT

1. This Agreement shall apply only to the District Manager, Deputy District Manager/Treasurer, District Engineer Roading and Design, and District Engineer Water and Drainage employed by the Rotorua District Council or its successor.

TERMS AND CONDITIONS OF EMPLOYMENT

2. (a) Subject to the provisions of subclause (b) of this clause, except where existing terms and conditions of employment are more favourable the provisions of the "Rotorua District Council Officers' Collective Agreement" and/or any subsequent amendment to that Agreement shall be deemed to be applicable to Officers covered by this Collective Agreement;

(b) Provided however, that while the salaries of Officers covered by this Collective Agreement are subject to the provisions of the higher Salaries Commission Act 1977, the salary provisions of the "Rotorua District Council Officers' Collective Agreement" shall not be applicable to Officers covered by

this Collective Agreement.

COMMENCEMENT DATE AND TERM OF AGREEMENT

3. This Agreement shall be deemed to have come into effect on the 1st day of October 1980, and this Agreement shall remain in force until superseded by a new Agreement arranged by the parties, such date to be not before twelve months following the commencement of this Agreement.
