REGISTERED COLLECTIVE AGREEMENT

SHADOW LAND PRODUCTIONS LTD ACTORS', ACTRESSES' AND RELATED PERFORMERS' IN FILM, VIDEO AND SOUND AGREEMENT

MATTERS NOT PROVIDED FOR

1. With the exception of the matters provided for specifically herein the terms and conditions of the New Zealand Actors', Actresses' and Related Performers' (Commercial and Film Performances Section) Award from time to time in force shall apply.

WORKING PERIODS

2. Workers shall be called, and payments shall be computed, in units of weeks, days and, in the case of extras only, half days; except that half day calls shall fall within the time periods 8.00 am to 1.00 pm, 12.00 noon to 6.00 pm and 5.00 pm to 12.00 midnight or shall be paid as a full day's call.

HOURS OF WORK

3. The ordinary hours of work shall be up to eight per day within a shift of ten hours, excluding meal breaks, on any five days of the week.

RATES OF WAGES

| 4. Performers shall be paid not less than the following rates of wages: | |

Provided that extras may be engaged en masse for crowd scenes.

LOCATION WAGES

5. Any performer required to remain away from his or her normal residence overnight shall either be paid by the week or, for any day that he or she is away from home but not called, receive a standby payment of not less than 48.00 per day.

TERM OF AGREEMENT

6. This agreement shall be deemed to have come into force on the 1st day of January 1981 and shall expire on the 31st day of December 1981.
