REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the Business Data Systems Limited Part-Time Shift Workers dispute of interest between the Wellington, Taranaki and Marlborough Clerical, Administrative and Related Workers Industrial Union of Workers and Business Data Systems Limited.

The Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

In witness of the registration of this collective agreement the seal of the Arbitration Court has hereto been affixed and a Judge of the Court has hereunto set his hand, this 23rd day of July 1981.

SUBMISSION OF VOLUNTARY SETTLEMENT FOR REGISTRATION

SPECIAL PART TIME SHIFT WORKERS AGREEMENT

In the matter of Business Data Systems Limited Special Part Time Shift Workers Agreement between the Wellington, Taranaki and Marlborough Clerical, Administrative and Related Workers Industrial Union of Workers and Business Data Systems Limited.

Whereas under Clause 7 (Shift Work) of the New Zealand Clerical Workers Award, Part Time Shift Workers may be employed on shifts by agreement between the employer and the local branch of the Union, it is hereby agreed that:

Where Business Data Systems Limited is engaged in the business of data input processing work and associated functions, and is not regularly operating two consecutive rotating full time shifts, it may employ part time shift workers whose employment shall be subject to the provisions of the New Zealand Clerical Workers Award and in accordance with the provisions of this agreement.

(i) A part time shift worker engaged under this agreement shall be employed for not less than ten hours per week, but not more than twenty hours per week, to be worked between the hours of 4.30 p.m. and 10 p.m. Monday to Thursday inclusive.

(ii) A part time shift worker shall be employed on no less than three days of the week, and all other relevant provisions of the Award shall be deemed to apply to the employment.

(iii) A part time shift worker shall be entitled to all shift payments provided for in the New Zealand Clerical Workers Award.

(iv) A part time shift worker employed under this agreement shall be entitled to annual holidays as provided for in Clause 10 (c) (Annual Holidays — Shift Holiday) of the New Zealand Clerical Workers Award.

(v) This agreement shall apply to the parties named herein in the Wellington Industrial District.

(vi) This agreement shall come into force on the 18th December, 1980 and continue in force until the 17th December, 1981.
