REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the Claycraft Potteries Limited Employees Dispute of Interest between Claycraft Potteries Limited and the New Zealand Labourers, General Workers and Related Trades Industrial Union of Workers (Northern Branch)

The Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

In witness of the registration of this collective agreement the seal of the Arbitration Court has hereto been affixed and a Judge of the Court has hereunto set his hand, this 25th day of June 1981.

CLAYCRAFT POTTERIES LIMITED EMPLOYEES – COLLECTIVE AGREEMENT – (VOLUNTARY)

This Collective Agreement made in pursuance of the Industrial Relations Act 1973 this 27th day of May 1981 between the New Zealand Labourers, General Workers and Related Trades Industrial Union of Workers (Northern Branch) 1–3 Galatos Street, Newton, Auckland (Hereinafter called “the union”) of the one part, and Claycroft Potteries Limited, Honan Place, Avondale, Auckland 7. (hereinafter called “the Employer”) of the other part, whereby it is mutually agreed by and between the parties hereto as follows:

1. That the wages and classifications contained in the schedule hereto be binding upon the parties. All other conditions and stipulations not provided for in this agreement shall operate as set out in the New Zealand Brick, Tile, Pottery and Porcelain Workers Award dated 11th day of May 1981.

The rates provided for in this agreement will not be altered during its currency, except for the application of General Wage Order and/or Cost of Living Orders which shall be applied according to their tenor. These wage rates listed below shall be increased by the 5% General Wage Order dated 21.5.81 and applying from 11th June 1981.

JOB CLASSIFICATIONS

2. (i) Hand throwing, blocking and casing.
- (ii) Mould making.
- (iii) Decoration, casting slip preparation.
- (iv) Casting, kiln work, and glazing.
- (v) Fetting and other work.

INTENT OF AGREEMENT

4. This agreement will apply only to job classifications and wage rates, all other matters shall be incorporated as per the New Zealand Brick, Tile, Pottery and Porcelain Workers Award and shall be read in conjunction with this agreement.

TERMS OF AGREEMENT

5. This agreement insofar as the rates of wages to be paid are concerned, shall come into force on the 2nd day of June 1981 and shall continue in force until the 1st of June 1982.
