## REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the Whirinaki Pulp Mill T.M.P. Conversion Construction Project Dispute of Interest between the Downer and Company Limited and the New Zealand Labourers, General Workers and Related Trades Industrial Union of Workers; the New Zealand Carpenters and Related Trades Industrial Union of Workers; Hawkes Bay Road Transport and Motor and Horse Drivers and their Assistants Industrial Union of Workers.

# WHIRINAKI PULP MILL TMP CONVERSION CONSTRUCTION PROJECT AGREEMENT

# SCHEDULE

# TYPE AND SCOPE OF AGREEMENT

- 1. (a) This Agreement is made between the New Zealand Carpenters and Related Trades Industrial Union of Workers, the New Zealand Labourers, General Workers and Related Trades Industrial Union of Workers, the Hawke's Bay Road Transport and Motor and Horse Drivers and their Assistants Industrial Union of Workers, (hereinafter called "the Unions") of the one part and Downer and Company Limited (hereinafter called "the Employer") of the other part and shall apply only to those workers who are employed by the Employer on the site of the Whirinaki Pulp Mill T.M.P. Conversion Construction Project and who are obliged in terms of one of the Awards listed in subclause 1(b) hereof to become or remain a member of a Union party hereto.
- (b) Except where varied by the terms of this Agreement all workers shall be employed in accordance with the minimum terms and conditions of the respective Awards. That is:
  - (i) The New Zealand (with exceptions) Building and Related Industries Tradesmen and Other Workers Award, or
  - (ii) The New Zealand Building, Quarrying, Contracting, Civil Engineering Constructional and Allied Industries Labourers and Other Workers Award, or
  - (iii) The New Zealand General Drivers Award.

# SITE AND INDUSTRIAL ALLOWANCE

2. A site and industrial allowance of 54.0 cents per hour will be paid to each worker for each hour he works on the site. This allowance is agreed as full compensation for the working conditions on or associated with working on the site, including locality, weather, and any factors associated with the operating mill such as possible noise, sawdust, smell, heat, pulp overflows and pulp dust, and in lieu of Award provisions for additional or special payments associated with working in the following situations:

Working at heights, working at depth, demolition work, gumboot money (sock allowance), working with bitumastic tar and oil, dusty conditions, Hiab operation, handling cement, using pneumatic or vibrating tools, sawing used boxing, grouting operations, concrete work, reinforcing steel work, scaffolding, welding, grinding operations, handling formwork, steam cleaning, multistorey work, repairs to pulp and paper mills, trailer allowances.

#### TERM AND ESCALATION

3. This Agreement shall apply with effect from the 1st day of April 1981 and shall remain in force for the duration of the Project, provided that on the 24th day of June 1982 and on the same day of any subsequent year the Site and Industrial Allowance herein prescribed shall be adjusted so as to restore the same proportional relationship with the rate prescribed for a Core Carpenter in the N.Z. (with exceptions) Building and Related Industries Tradesmen and Other Workers Award then in force to that which existed with the rate of \$4.963 per hour prescribed for that category of worker in that Award in force at the date of making of this Agreement.
