Under the Industrial Relations Act 1973  
REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the New Zealand Apple and Pear Marketing Board's Engine Drivers, Boiler Attendants, Firemen and Greasers Dispute of Interest between the New Zealand Apple and Pear Marketing Board AND the New Zealand Engine Drivers, Firemen, Greasers and Assistants Industrial Union of Workers.

The Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

In witness of the registration of this collective agreement the seal of the Arbitration Court has hereto been affixed and a Judge of the Court has hereunto set his hand, this 10th day of June 1982.

MEMORANDUM OF AGREEMENT BETWEEN THE NEW ZEALAND ENGINE DRIVERS, FIREMEN, GREASERS, AND ASSISTANTS UNION AND NEW ZEALAND APPLE AND PEAR MARKETING BOARD, WELLINGTON ON THE FOLLOWING TERMS APPLICABLE TO ENGINE DRIVERS FIREMEN ETC. EMPLOYED BY THE NEW ZEALAND APPLE AND PEAR MARKETING BOARD IN THE WELLINGTON AND NELSON INDUSTRIAL DISTRICTS.

DATED 12 MAY 1982

WAGES

Workers holding a second class certificate \$6.402 per hour.

Workers holding a Boiler Attendants certificate \$5.984 per hour.

Service Payments:

After six months' service 17 cents per hour

After 1 year's service increased to 24.5 cents per hour

After 2 years' service increased to 29 cents per hour

After 3 years' service increased to 33 cents per hour

After 4 years' service increased to 38 cents per hour

After 5 years' service increased to 42 cents per hour

After 6 years' service increased to 47 cents per hour

Crib Time Payment: Crib time shall be paid at ordinary time extra.

Meal Allowance: \$3.40.

Shift Allowance: \$4.33.

Change Over Payment: \$4.26 per week.

Water Treatment and Anti Pollution Payment: \$3.42 per shift.

Annual Holidays: One extra week after 6 years' service with the Company.

With the exception of the above all other conditions of the current New Zealand Engine Drivers, Firemen, Greasers and Assistants Award shall apply.
