REGISTERED COLLECTIVE AGREEMENT

In the matter of the Industrial Relations Act 1973; and in the matter of the Dannevirke County Council Technical, Professional, Administrative, Clerical and Other Employees' Dispute of Interest

between Wellington, Marlborough, Westland, Nelson and Taranaki Local Bodies' Officers Industrial Union of Workers and Dannevirke County Council

THE Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, provisions set out in the form of submission or notification attached hereto and orders:

1. That the said terms, conditions, and provisions shall be binding on the parties hereto; and

2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

In witness of the registration of this collective agreement the seal of the Arbitration Court has hereto been affixed and a Judge of the Court has hereunto set his hand, this 26th day of April 1985

**Terms of Voluntary Settlement under Section 65 of the Industrial Relations
Act 1973**

SCHEDULE

1. Notwithstanding the provisions of subclauses (a) (c) (d) and (e) of Clause 1 (Industry to which Agreement Applies) the Taranaki, Wellington, Marlborough, Nelson and Westland Electric Power Boards, Municipal, County Council, Catchment, Drainage, River Boards and other Local Authorities' Officers' Award dated 12th day of November 1981, together with any amendments thereof, and any Award made, or collective agreement duly registered in substitution therefore, shall apply to all salaried employees of the Dannevirke County Council with the exception of the Chief Executive Officer and County Clerk howsoever designated, but subject always to any relevant determination of the Higher Salaries Commission made under the Higher Salaries Commission Act 1977.
2. This agreement shall come into force on the day of the date hereof and shall continue in force for one year thereafter.

MEMORANDUM

This collective agreement incorporates the terms of voluntary settlement arrived at by the parties and forwarded to the Court for registration pursuant to section 65 of the Industrial Relations Act 1973.

Associated with the terms of settlement submitted for registration was an application pursuant to Regulation 13 of the Wage Adjustment Regulations 1974.

Following a hearing pursuant to subclauses (6) and (7) of Regulation 13 of the Wage Adjustment Regulations 1974, the Court has consented for the purpose of Regulation 13(5) to the inclusion in the above document of the indirect state linkage.

The document has been registered as presented but the Court expresses no concluded view as to the validity of the agreement in respect to the application of clause 1 as it applies to the Taranaki, Wellington, Marlborough, Nelson and Westland Electric Power Boards, Municipal, County Council, Catchment, Drainage, Riber Boards and Other Local Authorities Officers Award which continues to apply during the currency of this agreement.
