APPLICATION OF AGREEMENT

This Agreement shall apply to the Wellington District Hotel Hospital Restaurant and Related Trades Employees' Industrial Union of Workers, all workers employed at the Wellington Post Office Headquarters Building Cafeteria and the Post Office Headquarters Building Cafeteria Committee.

WAGES

Cooks shall be paid \$241.16 per week for weekly workers or \$6.029 per hour for part-time or casual workers.

All other workers shall be paid \$227.56 per week for weekly workers or \$5.689 an hour for part-time or casual staff.

3.

GENERAL

Except as herein modified the terms of employment of all workers bound by this agreement shall be in accordance with the terms and conditions of the New Zealand Tearoom and Restaurant Employees Award in force from time to time.

TERM OF AGREEMENT

This agreement shall come into force on the 30th day of July 1985 and shall continue in force until the 28th day of February 1986.
