between the Northern Hotel, Hospital, Restaurant and Related Trades Employees Industrial Union of Workers and Nationwide Food Services (N.Z.) Limited

THE Arbitration Court, having before it the terms of a voluntary settlement arrived at in the above-mentioned dispute of interest and submitted or notified to the Court pursuant to the provisions of section 65 of the Industrial Relations Act 1973, hereby registers as a collective agreement the terms, conditions, and provisions set out in the form of submission or notification attached hereto and orders:

- 2. That the said parties shall respectively do, observe, and perform every matter and thing by this collective agreement required to be done, observed, and performed, and shall not do anything in contravention of this collective agreement but shall in all respects abide by and perform it.

### Schedule

### 1. APPLICATION OF AGREEMENT

This Agreement shall apply to the Northern Hotel, Hospital, Restaurant and Related Trades Employees Industrial Union of Workers, all workers employed in the staff cafeteria at Fletcher Challenge House, Great South Road, Penrose, Auckland employed by Nationwide Food Services (N.Z.) Ltd.

## 2. WAGES

Amend the following clauses in the NZ Tearoom and Restaurant Employees Award by deleting the present provisions and inserting the following classifications and wage rates—

### 3. GENERAL

Except as herein modified the terms of employment of all workers bound by this agreement shall be in accordance with the New Zealand Tearoom and Restaurant Employees Award in force from time to time.

### 4. TERM OF AGREEMENT

This agreement shall come into force on the 21st day of August 1985 and shall continue in force until the 21st day of May 1986.
