SHIFT ALLOWANCE

In addition to the wages specified in the wages clause in this agreement an allowance of 25 cents per hour shall be paid to each worker which shall not count in the calculation of overtime and penal rates. This payment is in recognition of the special circumstances pertaining to the NZ Wire Industries Limited Site.
